



Lifetime Warranty ("Warranty") for Ezzy Fit Composite Materials

This Lifetime Warranty ("Warranty") applies to all Ezzy Fit composite materials ("Materials") purchased directly from Ezzy Fit Pty Ltd ("Company"). This Warranty is provided exclusively to the original purchaser ("Customer") and is non-transferable. To activate this Warranty, Customers must submit proof of professional installation by a licensed contractor or a recommendation and certificate from an Ezzy Fit-recommended installer.

1. Warranty Coverage

Ezzy Fit warrants that its Materials will be free from defects in materials and workmanship under normal use and proper maintenance for the lifetime of the Materials. This Warranty applies only when the Materials are professionally installed by a licensed contractor or an Ezzy Fit-recommended installer, following all applicable installation guidelines provided by the Company.

2. Proof of Professional Installation

To claim this Warranty, the Customer must provide proof of professional installation. Acceptable documentation includes:

A receipt or certificate from a licensed contractor, or

A recommendation and corresponding certificate issued by an Ezzy Fit-recommended installer.

The Company reserves the right to request additional documentation or verify the credentials of the installer.

3. Warranty Claims

If a defect covered by this Warranty arises, the Customer must notify the Company in writing within 30 days of discovering the defect. The Customer must include:

Proof of purchase,

Proof of professional installation, and

Supporting documentation for the claim.

The Company reserves the right to inspect the Materials and assess the claim to determine eligibility under this Warranty.

4. Warranty Remedies

If the claim is deemed valid, Ezzy Fit will, at its sole discretion, either repair or replace the defective Materials. The Company may use new or refurbished materials or components for replacements or repairs. This Warranty does not cover costs related to:

Removal of defective Materials,
Reinstallation of replacement Materials, or
Associated labor or transportation expenses.

5. Exclusions and Limitations

This Warranty does not cover:

- a. Fading, discoloration, or other aesthetic changes over time due to exposure to sunlight, weather, or other environmental factors.
- b. Damage resulting from improper installation, except when installed by a licensed contractor or Ezzy Fit-recommended installer.
- c. Misuse, abuse, neglect, or failure to maintain the Materials as per the Company's guidelines.
- d. Normal wear and tear.
- e. Accidental damage, vandalism, or force majeure events (e.g., natural disasters).
- f. Unauthorized modifications or alterations to the Materials without prior written approval from the Company.

6. Disclaimer of Warranties

This Warranty is the sole and exclusive warranty provided by the Company. No other warranties, express or implied, are made, including but not limited to implied warranties of merchantability or fitness for a particular purpose.

7. Limitation of Liability

Ezzy Fit shall not be liable for indirect, incidental, special, or consequential damages, including but not limited to loss of profits, business, or economic opportunities, arising from the use or inability to use the Materials.

8. Governing Law and Jurisdiction

This Warranty shall be governed by the laws of Queensland, Australia. Any disputes arising under this Warranty will be subject to the exclusive jurisdiction of the courts in Queensland.
